Mission Statement

The mission of the American Branch of the Richard III Society is to bring forward a historically-accurate, balanced, and fair assessment of a controversial English king, and to support educational initiatives to interpret his times. The Branch connects Americans with the global Ricardian community through joint membership with the Richard III Society (CLG) in the UK, and with one another by organizing events that expand on our knowledge of medieval history.

Who We Are

The American Branch was founded in 1961 and incorporated in 1968 as The Richard III Society, Inc. In 1970, the Branch was granted status as a non-profit educational organization under section 501c3 of the IRS code.

Members of the American Branch also hold membership in the original "parent society," The Richard III Society CLG of the UK.

The American Branch publishes its own *Ricardian Register* and *Chronicle* periodicals (each twice per year), and also distributes the Parent Society publications, the *Ricardian Bulletin* (quarterly) and research journal The *Ricardian* (annually), to all American Branch members.

The American Branch holds a General Membership Meeting at different locations around the country, or online as warranted, to conduct Society business and present relevant papers and presentations. The meetings are held in September or October every two years on even numbered years.

Membership in the Richard III Society is open to all. The Society's unique blend of professional scholars, theater professional and general readers with a love of history & literature fosters an especially vigorous exchange of ideas & information.

Who Was Richard IIII?

Richard III reigned from 1483-1485, and in that brief period became one of the most controversial kings in English history. His bad reputation is chiefly the result of the work of popular Tudor propagandists and authors, most notably Thomas More and William Shakespeare. The Richard III Society's purpose is to dig beyond these myths, and through rigorous research, help a more accurate, fair, and balanced picture of King Richard III to emerge.

- Born: 2 October 1452 at Fotheringhay Castle in Northamptonshire
- Parents: Richard, Duke of York, and his wife, the former Cecily Neville
- Youngest brother of King Edward IV
- Married to Anne Neville, daughter of the Earl of Warwick. Had one son. Edward of Middleham
- Fathered two other children, Katherine and John, before marrying Anne Neville
- Had scoliosis, not a hunchback, which was fully concealed when clothed
- Also known as: Richard, Duke of Gloucester
- Died: In battle on 22 August 1485 at Bosworth Field
- In September 2012 his remains were found under a car park within the site of the Grey Friars Priory in Leicester.

Programs and Projects

The William B. and Maryloo Spooner Schallek Memorial Graduate Fellowship Awards

Administered by the Medieval Academy of America he Schallek Awards program offers five annual dissertation awards of \$2,000 each and a dissertation fellowship of \$30,000 annually.

The Judy R. Weinsoft Memorial Research Library Fund

The Judy R. Weinsoft Memorial Research Library Fund supports the purchase of books for the Branch to keep pace with the explosion in fifteenth century studies and to give members access to the kinds of materials on Yorkist-era England found only in major library centers.

McGee Fund

The McGee fund is an endowed fund to provide Honoraria for our General Membership Meeting speakers.

Schallek Special Projects Fund

In addition to the Schallek Fellowship Awards, Maryloo Spooner Schallek established a fund to support young scholars of Richard III and his time period through high school essay contests and bursaries given to

undergraduate research projects. In 2009, this fund was expanded to include the Medieval Artifacts Conservation Fund, creating the "Schallek Special Projects Fund" (SSPF). This fund and member donations the American Branch supported preservation work on copies of the Edward IV Roll held by The Free Library of Philadelphia and University of Pennsylvania. More recently, we donated to the Wallace Collection (UK's premiere collection of medieval arms and armor).
