2022 Annual Report from the Membership Chair

Membership totals for the Richard III Society, American Branch had an overall increase in membership in 2022 from 329 to 356 members. In early 2022, the Richard III Society, CLG, in the UK began mailing Membership ID cards to CLG members in the American Branch. This is the first time that Membership ID cards from the UK have been sent to American Branch members, and indicates the we are indeed considered full members in the Richard III Society, CLG. The Membership ID numbers are the method in which American Branch members can register to attend the UK's Zoom presentations.

Mailings of the quarterly Ricardian Bulletin and the Annual Ricardian continue to be sent directly to American Branch members from the UK, with extra copies sent to me as the Membership Chair. The numbers of lost or missing publications from the UK has decreased dramatically, but it does reflect the need for American Branch members to keep the Membership Chair apprised as to changes of address (changes of address are then forwarded to our counterpart in the UK). Overall, the outlook from Membership continues to be promising and we expect continued growth in 2023.

Notes: Because the UK was late in billing us for the 10/2/2021-10/1/2022 CLG membership cycle, we incurred two years' worth of dues and overseas direct mailing costs in Fiscal Year 2022 to cover these expenses through 10/1/2023. We will try to ensure that the UK CLG sends us timely invoices, as we incur these expenses on 10/2 each year but cannot claim them as expenses until we actually pay the bill (we are on Cash Basis accounting).

2022 GMM Expenses were unusually high compared to past GMMs because of the 60th Anniversary celebration-related events and the extra Audio-Visual Technical costs associated with doing a Hybrid Zoom-In Person format. However, we have noted a past trend of GMM expenses exceeding income generated from GMM registration fees even before this new technology was employed.

We expect the UK CLG will be increasing its dues by almost \$4.00 per member, which will be an added expense for the American Branch in Fiscal Year 2023 (370 members x = 1,480).

Although not included in the spreadsheet above, members should know that the Board monitors the Schallek Endowment which funds the \$40,000 in annual scholarships distributed under the Schallek Fellowship & Awards program. The initial gift was \$1,340,000. It is managed by the Medieval Academy of America's financial manager (UBS Bank) pursuant to our contract with the Academy. At year-end 2022, the value was \$1,629,000.
